Protective gloves

Suitable chemical resistant protective gloves (EN374) also at prolonged, direct contact (recommended protection index 6, corresponding 480 minutes permeation time according to EN 374) e.g. from Nitrilkautschuk (0,33-0,5 mm) Polyvinylchlorid (1mm).

The glove material has to be impermeable and resistant to the product/ the substance/ the preparation.

Due to missing tests no recommendation to the glove material can be given for the product/ the preparation/ the chemical mixture.

Selection of the glove material on consideration of the penetration times, rates of diffusion and the degradation

· **Material of gloves**

The selection of the suitable gloves does not only depend on the material, but also on further marks of quality and varies from manufacturer to manufacturer. As the product is a preparation of several substances, the resistance of the glove material can not be calculated in advance and has therefore to be checked prior to the application.

· **Penetration time of glove material**

The exact break through time has to be found out by the manufacturer of the protective gloves and has to be observed.
